Jacquie explained the Northwest Ohio Early Head Start-Child Care Partnership (EHS-CCP) grant received on September 1, 2024, in partnership with HHWP (Hancock, Hardin, Wyandot, and Putnam) Community Action, was placed in the under-enrollment initiative according to a February 26, 2025, letter from the Office of Head Start. The under-enrollment plan is for 12 months, with a six-month follow-up period. GLCAP is currently at 98% of the goal; however, HHWP has 16 of 48 children enrolled, with 32 unfilled slots due to delays in building renovations. It is expected that HHWP will be able to meet full enrollment on or before the end of the initial 12 months.

Jacquie reviewed the Self-Assessment Improvement/Corrective Action Plans for Head Start/Early Head Start (HS/EHS), Early Head Start-Child Care Partnership (EHS-CCP), and Lucas County Head Start (HS) at GLCAP. The only corrective action plan was to meet an enrollment goal of 10% of children with disabilities for EHS-CCP and Lucas County HS. EHS-CCP is currently at 10.2%, while Lucas County needs only three more to meet the goal.

Upon motion duly made and seconded, the board unanimously

VOTED: to approve the Self-Assessment Improvement/Corrective Action Plans for Head Start/Early Head Start (HS/EHS), Early Head Start-Child Care Partnership (EHS-CCP), and Lucas County Head Start (HS) at GLCAP.

Staff recommended changes to the Early Childhood Program Priority Selection Criteria. There are now two different forms, one for families that only need childcare, and one for families that do not need childcare.

Upon motion duly made and seconded, the board unanimously

VOTED: to approve the changes to the Early Childhood Program Priority Selection Criteria forms.

Executive Committee Report – Cory Stine

The Executive Committee met on April 17, 2025, and approved proposals in the amount of \$6,572,715. These included the Child Development - Migrant Seasonal Head Start Continuation Grant and the Senior Services and Transportation - City of Fremont Community Development Block Grant (CDBG) and Sandusky County CDBG proposals.

Personnel Committee Report – Greg Edinger

Greg stated the Office of Head Start did not grant a COLA (cost of living adjustment) for 2025 because the federal government is operating under a continuing resolution, and our programs are flat funded for Fiscal Year 2025. No changes will be made to the pay scale base rates because of the flat funding. The Committee recommended a 1% raise for all eligible staff effective the first full pay period in June 2025, which complies with the wage article in the current labor agreement.

Upon motion duly made and seconded, the board unanimously

VOTED: to approve a 1% raise for all eligible staff effective the first full pay period in June 2025.

Planning and Evaluation Committee Report – Katie Schlagheck

Katie stated the Committee reviewed the Corporate Development Report for October 2024 through March

2025, the Customer Satisfaction Report for October 2024 through March 2025, the Community Service Block Grant (CSBG) Annual Report for 2024, and the CSBG MIS Report for January through March 2025. There were no concerns with any of the reports. The Committee was pleased to report that the results of the customer satisfaction report confirm our staff continue to meet or exceed customer expectations. Seven categories received exceptional scores, at 92% or higher, when adding agree and strongly agree responses. The eighth category scored 89%.

Development Committee Report – Stephanie Cavanaugh

Stephanie stated the Committee reviewed the 2025 People Helping People campaign materials. She stressed the goal of 100% Board participation.

Upon motion duly made and seconded, the board unanimously

VOTED: to accept the People Helping People Campaign materials as presented for the 2025 campaign.
