- Obtained summary judgment in favor of a property manager in a personal injury action arising out of a roof collapse (*See Osbourne v. Bone Roofing Supply, Inc.*, No. 1-14-2533, 2016 WL 4991342 (Ill. Ct. App. Sept. 16, 2016));
- Obtained summary judgment in favor of the City of Blue Island, Illinois and one of its police officers in a civil rights action arising out of the arrest, investigation, and prosecution of an individual for attempted armed robbery (*See Manning v. City of Blue Island*, No. 13-C-2214, 2015 WL 1538864 (N.D. Ill. March 31, 2015));
- Obtained summary judgment in favor of a tactical operations sharp shooting specialist in a wrongful death action arising out of a barricaded gunman stand-off incident in which the gunman opened fire upon an armored BearCat SWAT vehicle occupied by multiple law enforcement officers;
- Collected a judgment in excess of \$1,000,000 on behalf of a corporate client in a breach of contract action where the defendant was located on the Caribbean island of St. Kitts, held no assets in the United States, and refused to pay the judgment.
